In the letters, we strive to publish a mix of opinions and ideas.

We edit and fact-check each letter.

Writers may express their opinions, but may not spread misinformation.

Letters about local issues and those in response to a Herald-Tribune story are preferred.

We also give priority to letters that are timely, accurate and well written.

What constitutes an effective Letter to the Editor?

A good letter:

Is focused on one topic.

Is concise and engaging.

Is fact-supported.

Is at or below a paper's word count.

The Letters Editor carefully fact checks and edits submitted letters

Illustration of the Letters Editor Fact Checking and Editing a letter to make it better. The letters headline and first paragraph follow:

Banning vaccine passports is absurd

U.S. Rep. Vern Buchanan, R-Longboat Key, emailed his constituents this week, writing: "I wanted to let you know I just co-sponsored legislation to ban the federal government from issuing vaccine passports."

The Letters Editor began her review of my letter by checking whether Buchanan had co-sponsored the legislation. She shortly emailed me that he was not on the list of co-sponsors. I sent her a copy of Buchanan's email that established that he had made the false statemen and she left it in the letter.

I carefully observed the Herald-Tribune's 200-word count, so my submitted last paragraph was very brief. It simply stated that to achieve herd immunity an estimated 70% would have to be vaccinated. The Letters Editor rewrote and expanded the paragraph supporting the herd immunity issue with a fact-based statement from the Mayo Clinic saying 75% was required to achieve herd immunity. The revised paragraph follows:

If many Americans refuse to get vaccinated, this will prevent the country from reaching the percentage of the population necessary to create herd immunity...To reach herd immunity, an estimated 75%, or more than 200 million people, will have to be vaccinated, according to the Mayo Clinic.

Please wear a mask and get vaccinated!

Probably the biggest challenge for a newspaper letters editor is how to address false facts versus permissible ignorant opinions.

How the Letters Editor addresses false information.

The essential need to be vaccinated for Covid-19 has been challenged by an amazing host of false statements that have politicalized a medical science issue. One false statement circulating is that if you had Covid you do not need to get vaccinated.

The Herald-Tribune published a 200-word letter on September 18, 2021 that defends that position, by Andrea Hume, MD, "a physician-trained medical outcomes analyst who has advised health plans" ...

In her letter she supports her position with the following false statements:

"...In an Israeli study, 7% of vaccinees with prior COVID infection required emergency care or hospitalization after receiving a single dose of the Pfizer vaccine...

...Those with prior COVID or a positive antibody test should be excluded by policymakers from any vaccination requirements."

The Letters Editor posted the following note to the conclusion of her letter:

Editor's note: The Israeli study has not been peer reviewed or endorsed by the scientific community. The CDC recommends that those who have recovered from COVID be vaccinated to prevent reinfection.

This is an excellent example of an **Opinion Letter** – that does not spread factual misinformation and is in compliance with the Herald-Tribune's policies. Read this letter carefully and you will realize that the writer is forcefully expressing his opinion, that you will not like, but he does not represent those opinions as facts!


Also, I believe most Americans would not argue with governors trying to protect our borders, while Biden lets hundreds of thousands enter illegally.
